Dear Mr. Paff:

The purpose of this letter is to apprise you of the Local Finance Board's final disposition of the above referenced complaint.

As you are aware, the Local Government Ethics Law, N.J.S.A. 40A:9-22.1 et seq., provides the Local Finance Board with the power to initiate, receive, hear, and review complaints, and hold hearings with regard to possible violations of the Local Government Ethics Law, where no local ethics board has been established, and determine if a complaint against a local government officer or employee is within its jurisdiction, frivolous, or without a reasonable factual basis, prior to conducting an investigation.

Complaint LFB# 08-007 was filed against Mr. James Coviello in the Town of Guttenburg for failure to file 2008 Annual Financial Disclosure Statements (FDS).

The Local Government Ethics Law states:

**N.J.S.A. 40A:9-22.6(a) Local government officers shall annually file a financial disclosure statement.**

FDS filing for the individual named in your complaint has since been received and therefore satisfies N.J.S.A. 40A:9-22.6(a). In accordance with N.J.S.A. 40A:9-22.9, the Board determined that this matter would be frivolous to pursue because the deficiency cited in the complaint has been satisfied.

Please note that the Board is considering implementation of a stricter policy of fining local government officers who fail to file annual financial disclosure statements in a timely




manner. However, pending advance notice of such a policy, the past policy of not fining officers who file statements in response to complaints will continue.

A copy of Mr. Coviello's 2008 FDS is enclosed and LFB Complaint #08-007 is now closed.
