

RELEASE

This Release, dated 2/21, 2012, is given by the Releasor, Susan O'Neil referred to as "I"/"Me", to the Borough of Haddon Heights referred to as "You".

If more than one person signs this Release, "I"/"Me" shall mean each person who signs this Release.

1. **Release.** I release and give up any and all claims and rights, which I may have against you. This releases all claims, including those of which I am not aware and those not mentioned in this Release. This Release applies to claims resulting from anything, which has happened up to now. I specifically release any and all claims under the New Jersey Open Public Meetings Act. I acknowledge that I will be reimbursed \$260.00 for the cost of this suit.

It is expressly understood and agreed upon that the acceptance of the said amount is in full accord and satisfaction of and in compromise of all disputed claims and that the future action thereof is not an admission of liability or responsibility, as this Release is being given as part of an amicable settlement negotiated on behalf of Releasees.

2. **Future Action.** I agree in the knowledge that I have not received any financial consideration in making this release. The Borough of Haddon Heights agrees, in the future, to do the following with respect to motions or resolutions for closed session pursuant to the Open Public Meetings Act:

1. Advise the public on its agenda that action may be taken at the end of the closed session, if applicable.
2. Disclose as much information about the nature and topic of the closed session discussions as possible without harming the public interest or the Borough's interest in keeping the matter private.
3. In the event that the closed session discussion involves active litigation which is in suit the Borough will identify the case name and docket number.
4. Include in the resolution to go into closed session an estimation of time the closed session will require and advise the public of the anticipated time the governing body will return to the public session.
5. To the extent possible advise the public when the minutes of the closed session will be available to the public.
6. Nothing in this release will prevent the plaintiff from seeking any minutes adopted at the February 7, 2012 meeting.


I agree that I will not seek anything further including any payment or other relief from you.

3. **Who is Bound.** You and I are bound by this Release. Anyone who succeeds to my rights and responsibilities, such as my heirs or the executor of my estate, is also bound. This Release is made for your and my benefit and all who succeed to your rights and responsibilities.

4. **Signatures.** I understand and agree to the terms of this Release. If this Release is made by a corporation its proper corporate officers and its corporate seal is affixed.




