ORDINANCE 8-2013

AN ORDINANCE TO AMEND THE LAND USE DEVELOPMENT LAW OF THE TOWNSHIP OF GREENWICH TO PROVIDE FOR NOT MORE THAN FOUR ALTERNATE MEMBERS

WHERAS, the Greenwich Township Committee believes this amendment to be necessary and expedient to best serve the residents of Greenwich Township and therefore does hereby formally amend Greenwich Township Land Use Law to provide for the appointment of not more than four alternate members to the Combined Board pursuant to N.J.S.A. 40:55D-23.1. The alternate members shall serve consonant with N.J.S.A. 40:55D-23.1 and other applicable provisions of the New Jersey Land Use Law.

Section One. Repealer. All former Ordinance of the Township of Greenwich which are in conflict with the provisions contained in this Ordinance are hereby repealed upon the adoption of this Ordinance.

Section Two. Severability. If any part or parts of this Ordinance are held to be invalid for any reason such decision shall not affect the validity of the remaining portions of this Ordinance.

Section Three. This Ordinance shall take effect after final approval and publication as required by law.
