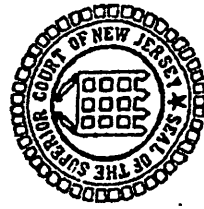


I, Carla Smith, duly sworn upon my oath do hereby certify as follows:
