Pursuant to the attached accumulated time, supplied by the Police Payroll Dept., the following computations will be minus any time Ptlm. Voll would have earned for the month of December, as his resignation was effective 11/26/82.


180 Compensatory Hours	17½ Days	→ This figure would be 22½ days, however, Ptlm. Voll exhausted 40 hours from 11/22/82 up to and including 11/26/82.
Sick Days	0	→ Must have 15 years of service in order to get any percentage of sick time.
Vacation Days	1 Day	→ 1 day minus month of December.
Holidays	4 Days	→ Minus Christmas.
13 day pay Voll earned while on shift work	7 Days	
	<u>29½</u>	- TOTAL ACCUMULATED DAYS.

In order to arrive at the dollar amount to be paid out, note the following:

\$22,613 (Voll's Yearly Salary) + 904.52 (Current Yearly Longevity Pay)  
= \$23,517.52 ÷ 261 (1982 days worked)  
= \$90.11 (1982 per diem rate) X 29.50 (Total accumulated time)  
= \$2,658.25 - Total amount Voll is to receive as a result of his resignation.
