
IT IS FURTHER ORDERED that plaintiff's specific claims of defamatory conduct are dismissed with prejudice as follows:

4. Plaintiff's Complaint regarding Statements made by Daniel Krushinski during a May 25, 2010 Franklin Township Council meeting is hereby dismissed with prejudice.
5. Plaintiff's Complaint regarding Statements published on Station 25's and Station 27's websites is hereby dismissed with prejudice.
6. Plaintiff's Complaint regarding the anonymous letter is hereby dismissed with prejudice.

IT IS FURTHER ORDERED that plaintiff's case is limited to whichever of the specific claims of defamatory conduct outlined herein that are not dismissed by this Order.
