**Affordable Housing**

The owner of [REDACTED] Court (an affordable housing unit) was granted a hardship waiver to improve it from a low to moderate income unit because there were no low-income eligible buyers that could buy the unit and if she made it a moderate she would have a larger pool of prospective buyers. With that, the Affordable Housing Board granted the waiver and she entered into a contract with a gentleman for the purchase; however, the purchase did not materialize because he has not been able to acquire financing. She has continued to try to market the property; but, has come back to the Board to ask that the property be removed from the program as no buyers are eligible to obtain financing. The Board did not grant the hardship waiver.



This situation is out of the ordinary. The properties we have purchased in the past have been from sheriff's sales or from the bank when the property has gone into foreclosure. This approach, however, will allow the Township to keep this property in the affordable housing inventory.

**The question arose as to whether or not this would be precedent setting and It was thought that it probably would not because the time factor of the property coming out of the program could be used as the parameter for the property purchase along with the benefit of keeping the property in the Township's Inventory.**

**Township would have to pay for the search, the repairs. The end result would, at best, be a break-even situation.**

**After discussion the consensus was to attempt to buy the property to keep it in our inventory especially because it comes out of Inventory in 2017.**

As an hourly employee, he will not be receiving benefits. Benefits will be received when and if the position becomes a permanent full time position.

At some point in time, a transition from [REDACTED] to a new [REDACTED] will have to be a consideration and a plan developed. As everyone knows [REDACTED] does far and above what is required of a 'normal' [REDACTED] and a plan for his replacement will be a necessity.

**Acquisition of Land**

**Mr. Krawczun reported to Council that he was approached by Hopewell Township to share in the cost of purchasing a 170-acre parcel of land on Carter Road. Some of the parcel has been preserved as a result of a resolution of memorialization requiring that the developer turn over land as square footage is developed. They are now in litigation because BPG is telling Hopewell Township they could not perfect our 800,000 sf, so therefore they are not obligated to perform all of the conditions of the approval. Hopewell Township is seeking participation from various towns - Lawrence, Pennington, Hopewell Boro and Princeton. Princeton has already expressed interest in participating in the purchase. One question that must be answered prior to Lawrence joining in the purchase is, what is the benefit to Lawrence; to which Mayor Sandom felt there were two benefits; one being the installation of the Lawrence Hopewell Trail and the preservation of land would reduce the 800,000 square feet of buildable space which would result in less traffic.**

**This joint venture would have no negative impact on the Township's ability to obtain future funding from Mercer County according to Donna Lewis. Money for this project will not come from Township funds - only from open space funding from the County.**

**An additional future issue with this purchase could be sewer service to the area and ultimately to The Lawrenceville School - so that also has to be a consideration.**

**The concensus of Council was for Mr. Krawczun to talk to Hopewell Township to get additional information relative to questions that the Council raised during discussion of this matter.**

**Council Meeting Room Security**

Mr. Krawczun advised Council of proposed security measures for the Council Meeting Room and other areas of Town Hall.

Councilmember Powers excused himself prior to the start of the following matter due to a conflict.

**Cable Television - Comcast**

Mr. Krawczun distributed documents relative to the cable television franchise renewal for Comcast to include:

- 1997 Ordinance
- Summary of what the Cable Telecommunications Committee assembled as some of its requests.
- Draft Ordinance that would replace the 1997 Ordinance to renew the franchise in Lawrence Township
- Detail summary of revenue received from Comcast and Verizon from the franchise fee

Mr. Krawczun explained the very radical amendments to the franchise renewal legislation and Administrative Code that occurred once Verizon was given the ability to have a state-wide franchise and not having to negotiate with each individual municipality. These changes resulted in the towns being extremely restricted in what can and cannot be negotiate. Given the fact that the Township was not in a position to heavily negotiate, the Cable Telecommunications Committee did an outstanding job and conducted a considerable amount of research. The draft ordinance will have to go to the BPU for review and approval.

We are also waiting for the school district to give its approval because there are matters in the first ordinance that no longer exist in this ordinance related to what is referred to as the "B" cable that Comcast was maintaining for them. The original ordinance called for a contribution of \$50,000 towards

**the school's television studio. The school is now in discussions with Comcast and will have some of their technology upgraded and the cables changed from copper to fiber.**

**He further highlighted some issues such as the duration of the franchise which was previously 15 years and Comcast is asking for a 15 year franchise with a 10 year automatic renewal. This is consistent with other communities. A lesser period will result in Comcast giving the Township less technology funding. They are proposing a \$50,000 technology grant and if it goes to a 15 year franchise grant funding reduces to \$10,000.**

**If a franchise renewal period cannot be agreed upon, Comcast can take this to a system-wide franchise which goes to the BPU and if they are given approval, they have their own franchise and the Township has no say in that process.**

**The franchise fee was 2%; but, once Verizon reaches the ability to service 60% of the residents, the franchise fee goes to 3.5%. As you are aware, it is a 4% franchise fee; but, the ½ percent goes to the State. Verizon is currently paying the 3.5%.**

**Conversation took place with Comcast relative to repairs - If there are complaints about service or installation or equipment, they are handled by the CTAV. And one of the complaints is that Comcast hires independent contractors to install or repair equipment and they leave things in an unsightly condition and we requested a requirement that those repairs be completed within 30 days and we did manage to get Comcast to agree to make an effort to complete restoration to the satisfaction of the resident within the 30 day time period. This was a major concession on the part of Comcast to agree to this stipulation.**

**Additional conversation took place relative to items contained within the draft ordinance to include technology changes that will take place over the life of the contract and per the BPU there cannot be a 're-opener' clause included for this. Customer service was also discussed as to how far from the Lawrence border a customer service facility could be and the BPU said that this cannot be a requirement. Another change will be that Comcast will provide the Township with its own PEG channel so we will no longer have to share with the school's PEG channel. If Comcast wants to use this channel during fallow time it will require a 60 day notice and should the Township wish to broadcast something we will need to give a 60 day notice to Comcast if they have taken over the fallow time.**

**The bonding clause contained in the ordinance at \$25,000 is for small work that needs to be done. Performance bonding is overseen by the BPU. The complaint office for performance is not the Township; it has to be the Complaint Office at the BPU.**

**If Council approves the contract and the technology grant is given, a portion of the money will be used to provide monitors in the Council Meeting Room so when a power point presentation is given it will be more visible from various locations in the room and equipment improvement has also been discussed for the Lower Level Conference Room. Additionally, some upgrades will be made in equipment in the Police Department for emergency response/management use.**

**Mr. Krawczun asked Council to review the material and if there are any questions, he will be happy to answer them and if there is a consensus from Council and when the Cable Telecommunications Advisory Committee gets its review to him, the contract will be forwarded to the BPU for its review.**

**Additionally, Comcast will also continue to provide services free of charge to the various Township facilities.**

**The owner/applicant came to the Township to inquire as to whether the Township would accept the idea of removing the four residential components located on the second floor of the project. The project is approved and just needs his architectural drawings signed off on and then he can file for his permits.**

**Also at that meeting a buyer for the project came with him and they also wanted to get the project started without the residential component.**

**During the meeting Mr. Krawczun asked the owner if the residential portion would be more desirable if assistance were given to him relative to the units becoming affordable housing which would include monetary incentives. The owner declined the offer insisting that they did not want to become residential landlords.**

**The buyers came to the Township on a couple of occasions with some changes to the elevations which the Township might want to see by eliminating the second floor; however, what we wanted to avoid was a Hollywood type set design where there would be windows on the 'second' floor. This is not something that the Township would support. Either way, the change would require Planning Board approval. At this point in time there has been no contact by the buyers. However, the owner did come back to the Township and indicated that he wants to complete the project and now wants to hear more about the affordable housing contribution.**

**In the meantime, the owner of the strip stores across from the Shopping Center approached Jim Parvesse. He was to the Planning and Zoning Boards for his project when he wanted to open a convenience store which was a non-permitted use on the site for which he received approval and he then banked 3 parking places. There is a question on whether or not you characterize the Dunkin Donuts either as a convenience store or retail - will it change the parking demand. And, the 3 banked parking places were set aside for the convenience store Subs and Bites. In conversation it was discovered that this owner and the owner of the Whitehead Road site are in competition for the Dunkin Donuts franchise.**



**Mr. Krawczun revisited the affordable housing discussion that took place during the closed session of April 1<sup>st</sup> relative to the situation with the handicapped children and further advised he spoke to Mr. Caton and it is felt although it may be permitted it is not certain how it will come out under the new COAH requirements.**

**At this point this issue should be left on hold until the new COAH regulations come out and then the matter can be revisited, if Council do desires.**

**Labor Negotiations**

**Mr. Krawczun informed Council that he still has negotiations open with two of the labor unions: the CWA which is a small group of supervisors and the second is the EMTs, another very small group.**

**The issue that is holding up settlement is a provision under the Affordable Care Act wherein language was proposed that all employees and retirees on or after 12/31/14 that choose an employer-sponsored health insurance plan where the premium triggers an Excise Tax in accordance with the Affordable Care Act, then the cost of the tax will be the responsibility of the employee requiring a contribution in the amount of the Excise Tax in addition to the contribution required by employees and retirees covered by the collective bargaining unit.**

**These two unions are pushing back on that issue because the employees are already contributing. The threshold is approximately \$27,500 and the EMT representative was under the impression that there is a waiver to a higher threshold for employees who are considered to have hazardous professions. This factor was investigated and it is the feeling of the administration that this does not apply to the EMTs. A waiver, can in fact be made; however, you must have the majority (50% +1) of your employees in those positions.**


**Mr. Krawczun's feeling is that the taxpayers of Lawrence Township are paying for the health coverage of the employees through their taxes. And, yes, the employees are contributing toward those premiums. The Township, as an employer, participates in the State Health Benefits program. There are options for the employee to select a plan that is less than the threshold. The employee can have the plan; but, if you want the plan you are going to pay the Excise Tax. Residents should not be asked to pay twice for the same coverage.**

**Other unions that have settled have accepted and compromised on that language.**

**The CWA and EMTs are resistant to this factor.**

**Mr. Krawczun advised Council that he will remain firm on this issue to which Council concurred.**



**Labor Negotiations**

Mr. Krawczun brought Council up to date advising that the Blue Collar Union settled with no COLA for 2014; 1.95% in 2015 and 2.25% in 2016. This matches the wage increase that the Police received. Employees will receive a step increase if they are not at the top of the range. Employees at the top of the range will receive a \$500 one-time payment that would not be calculated as part of their pensionable salary. Longevity is frozen at its current rate as to what the employee was receiving at the end of 12/31/13.

Employees are currently being paid for unused personal days and that will continue.

There will now be two salary guides for Blue Collar and White Collar unions. For employees hired on or before 1/1/14 the salary guide would reflect COLA; if hired after 1/1/14 the employee will move up on the salary guide; but the steps are not adjusted for COLA until you get to the top of the range. Blues have 12 steps and Whites have 11 steps.

Limits will be placed on compensatory time; language change relative to working before and after a holiday and the type of time that can be used; those hired after 1/1/14 will no longer be eligible for sick leave payment upon retirement; vacation days also reduced for hires after 1/1/14; employees went onto the Matrix for health benefits contribution and contribution for retirees after 2/2/14 increased to 1%; after 2/1/15 increased to 2% and after 2/1/16 increased to 2.5% of their pensionable amount.

Under the White collar contract some employees are provided a clothing allowance for field work; this has been changed wherein the benefit level remains the same; but, the Township will furnish the clothing. The inspectors will now have shirts that will have their name with the Township logo on it which will let the residents know they are, in fact, Township employees.

Under the Affordable Health Care Act there is an Excise Tax to be paid by the employee if the premium exceeds a \$27,500 threshold (which will be indexed). The employer is responsible for 40% of that tax. The unions agreed to language that if the plan chosen by the employee triggers the tax, then the

employee will pay the tax. Alternatives are offered under the State Health Benefits plan that will not trigger the tax. The effective date for this is 2018.

The CWA advised they are not agreeing to the 2018 regulations because it is too far in advance and discussions for settlement are ongoing.

Other small items were discussed and are outlined in the Agreement.

The consensus of Council was to authorize the Manager to prepare a resolution adopting the Bargaining Agreements between the Township and the Blue and White Collar unions for adoption at the Council meeting of January 21<sup>st</sup>.

Non-Union employees will follow these same guidelines.

#### Personnel Matter


Mr. Krawczun advised Capital Health will no longer provide emergency dispatch services for LifeCom of Mercer, effective May 1, 2014. Present at a conference call were Mayor Lewis, Jack Oakley, Director of Emergency Management Services and Chief Ubry. One of the difficulties coming upon us is that by May 1<sup>st</sup> there is little chance that there will be a regional service. Capital Health advised us that they had informed Mercer County as long as nine months ago to try to regionalize this service and that obviously did not occur.

Our first step will be to create a contingency plan as to how to provide this service effective May 1<sup>st</sup>. Jack Oakley and Mark Ubry will work on that plan and our concern is that under the LifeCom program there is the ability for dispatching mutual aid of ambulances.

Step two will be to proceed with maintaining our ambulance service.

The Mayor will be reaching out to the other towns in the County to develop a long range regionalized service.




**Richard S. Krawczun, Municipal Manager and David M. Roskos, Esq., Municipal Attorney, were also in attendance.**
