

4 HJ: That is correct.

5

6 KR: And in your own words, can...let's start with the motor vehicle stop that was  
7 January 20<sup>th</sup> ?

8

9 HJ: At approximately 9:30...9:33 am

10

11 KR: Okay, and did you happened to have the occasion to stop a vehicle?

12

13 HJ: Ah, yes I did. While running a fixed radar on Trenton Avenue, going southbound,  
14 on to 29 southbound, I observed a pickup truck traveling at a rate of 45 miles an  
15 hour, at which time, a motor vehicle stop was conducted with that vehicle.

16

17 KR: Okay

19 HJ: It's that driver, Mr. SpoKR.

20

21 KR: Okay. Was there anybody else in the car? Or in the truck?

22

23 HJ: Yes, there was a second passenger in that vehicle.

24

25 KR: Okay. And that motor vehicle stop, that was recorded on the MVR?

26

27 HJ: That is correct.

28

29 KR: Okay. And that was from the initial stop until completion?

30

31 HJ: From start to finish.

33 KR: Okay, very good. And if I could just ask you to take a look at this summons,  
34 B023961, if you're familiar with that?

8 particular summons.

10 KR: Okay. Did you...did you check his history in the computer at all? Do you have  
11 MDT's in your car?

12

13 HJ: Yes we do, we do.

14

15 KR: Okay. Do you recall if you ran him or not?

16

17 HJ: I do not recall.

18

19 KR: All right. And upon going back to your car, you issued a summons...?

20

21 HJ: I did issue a summons. I cut the individual a break. He was clocked at 45 miles  
22 an hour in a 25 miles an hour speed zone and I told him I would write him for 5  
23 over, to not make it so severe point-wise for him. And this is just something I was  
24 doing, at my discretion.

25

26 KR: All right, and using your discretion. And have you done that in the past to other  
27 motorists?

28

29 HJ: Absolutely, yes.

30

31 KR: All right, so what...did you know Mr. SpoKR prior to this?

32

33 HJ: Never met him before.

34

35 KR: Okay. And you...like you've said, you've done that to other drivers, where you used  
36 your discretion, maybe you check their driver history...you start off...

16 go about handling these matters. That was pretty much my contact with him.

17

18 KR: All right. And what was your intention for that? How he can dispose of it? Pay it,

21 HJ: Nah, how he could actually, we would actually take it back up...it...when I do these  
22 tickets, I'll actually write the actual speed. So, if there's a situation where we're  
23 going to work something out, it's going to go back to that 45 miles an hour, and  
24 then we'll downgrade it. So, if it's a three or four point ticket, and now goes down  
25 to a two point ticket.

27 KR: Okay. I see you have 45 circled here?

29 HJ: Correct

31 KR: So, the Prosecutor would know that the initial speed...

28 Delaware Valley, and what did you observe when you were out there?

30 HJ: On my arrival there for this court session, when I walked into the building, I  
31 observed Mr. SpokR seated in the back row, at which time I proceeded upstairs to  
32 where the Prosecutor, the...I guess you would her, the Court CleKR, that handles  
33 all the finances, and Chief Kurylka were all sitting there. So then as I walked up, I  
34 observed Mary Mott and said, I see your guy's there. What do you want to do  
35 about the ticket. At which time she said, "Don't worry about it, it's already been  
36 taken care of." And with that said, you could see the Chief look up like...well, the  
37 officer just got here...how could it be taken care of? There's been no dialogue.  
38 Look, and I don't remember, again, sitting here, I don't remember what business  
39 they were saying to each other, but I know that...I knew that the Chief was not  
40 happy with what he had heard.

2 KR: Okay, so the ticket was already taken care of? What time did you get to court at?  
3 Do you remember?

4  
5 HJ: Um, probably about maybe 2:15. I don't know. I should...it should be on...I  
6 haven't...the patrol log? But I didn't...

7  
8 KR: All right, if we could get a copy of just the log... for...

9  
10 HJ: Yeah...for that day...

11  
12 KR: ...for March 8<sup>th</sup>? All right. Very good. Um, all right, do you CAD off with  
13 communications when you go to court?

14  
15 HJ: Yes

16  
17 KR: All right. So we would have the CAD record too of what time you got there at.  
18 Okay, so when you got there, you saw Mr. SpokR...

19  
20 HJ: He was seated down in the court room, as I go upstairs, there's Mary Mott, there's

23 KR: But if it was already disposed of, why would he still be sitting there? If it was  
24 already heard?

26 HJ: It's my understanding, with court practices, that anything that's going to be  
27 dismissed, for trial, are heard at the end of court.

28  
29 KR: Trials are heard at the end?

30  
31 HJ: Right. So, anything that they can dispose of quickly, they'll handle that first...

35 HJ: And then if there's trials, or if there's something where there's going to be a  
36 dismissal, or they have to put something on the record, it's always held at the end.



During a meeting with the Police Committee, said meeting attended by the Mayor, the Police Commissioner, Police Chief and myself. This matter was brought to their attention and they were informed this matter would be brought to the attention of Municipal Court Judge Novak and the Hunterdon County Prosecutor's Office.

Monday 03-26-2012

At 0915 hours, Chief Kurylka and I spoke via telephone with Judge Novak and were informed he would be responding to police headquarters to speak to us. At 1020 hours, Judge Novak arrived at police headquarters and was informed of the situation. He responded by stating he would be reinstating the summons, B023961, because he had now been informed that the reason for the dismissal may not be true. The Hunterdon County Prosecutor's Office was notified by Chief Kurylka and a meeting was set for 03-28-2012.

Wednesday 03-28-2012

Chief Kurylka and I met with the Hunterdon County Prosecutor, Mr. Keams, and his Chief of Detectives and Assistant Prosecutor. All information was related to them and we were informed their office would be conducting an investigation into the matter.

Monday 04-02-2012
