ORDER

This matter having been originally opened to the Court by the Law Office of Walter M. Luers, LLC (Walter M. Luers, Esq. appearing), attorney for Plaintiff John Paff, by way of Motion for Partial Summary Judgment and the Court having conducted an *in camera* review of certain documents and records pursuant to the December 16, 2011 Order of the Court, and having heard oral argument on May 7, 2012, and **for the reasons set forth on the record on May 7, 2012**, it is on this 30 day of May, 2012:

ORDERED that (1) Defendants shall provide to Plaintiff an unredacted copy of Defendants' July 28, 2010 executive session meeting minutes; (2) Defendants shall provide to Plaintiff an unredacted copy of Defendants' August 26, 2010 executive session meeting minutes; (3) Defendants shall provide to Plaintiff an unredacted copy of Defendants' February 2, 2011 executive session meeting minutes; (4) Defendants shall unredact and disclose to Plaintiff the names of individuals present at the first and second executive session meeting minutes dated February 23, 2011 to the extent not already disclosed, and, in addition, Defendants shall amend and augment their first and second executive session meeting minutes for February 23, 2011

such that they are reasonably comprehensible and include sufficient information to permit the Court to make a finding regarding whether the remaining redacted portions of those documents should be disclosed to Plaintiff, including but not limited to the identity of the counterparty to the "tentative agreement" and "negotiations" referenced in those minutes; and it is further

ORDERED that the redaction of the March 2, 2011 executive session meeting minutes is permitted, however Defendants shall identify to Plaintiff the identity of the counterparty to the negotiations discussed in those minutes; and it is further


ORDERED that Defendants shall provide redacted and unredacted copies of the following Board executive session meeting minutes to the Court for *in camera* review to determine whether the redacted portions thereof should be produced to Plaintiff in whole or in part: March 24, 2010 (session 2); April 28, 2010; May 26, 2010 (session 1); May 26, 2010 (session 2); June 23, 2010 (session 1 only); September 22, 2010; and December 15, 2010; and it is further

ORDERED that the documents or information that are required to be provided to the Court or Plaintiff or the acts that shall be performed by Defendants in the preceding paragraphs shall be performed within seven days after service of this order upon them;

ORDERED that the prior orders of this Court to the extent not inconsistent with this Order remain in effect; and it is further

ORDERED that a case management conference be held in this matter on June 25, 2012 at 8:45 a.m./p.m.; and it is further

ORDERED that Plaintiff's counsel shall serve a copy of this Order upon Defendants within 7 days of its entry and return.
