On 09/16/08 I was dispatched to 1035 Wayside Rd. for a report of a past dispute. When I arrived there I spoke to Mr. [REDACTED] stated he is a bus driver for Murphy Bus and this morning on his route he was confronted by a parent from [REDACTED] later identified as Dean Duane. [REDACTED] stated when he arrived at [REDACTED] Rd. to pick up a child the child was laying in the driveway and wouldn't get on the bus. After waiting several minutes he had to continue with his route so he drove off. When he was heading back on Swimming River Rd. Mr. Duane was standing in the middle of the road by the church. He stopped the bus and Mr. Duane attempted to gain access to the bus. Since Mr. [REDACTED] did not know what Mr. Duane was going to do he wouldn't let him on the bus and he started to drive off. At this point Mr. Duane jumped onto the bus and was hanging from the passenger side mirror. Mr. Duane eventually let go and Mr. [REDACTED] continued on his way. When he arrived at Swimming River School Mr. Duane attempted to confront him and words were exchanged between the two parties.

At this point Mr. [REDACTED] does not want to sign complaints and only wants the incident documented. Mr. [REDACTED] was also informed that Mr. Duane is a Tinton Falls Police Officer and what he would need to do in order to file an internal complaint against him, but he did not wish to at this time. He only wanted to make sure there would not be any future incidents. Sgt. Jellinski responded to the scene and informed Cpt. Trevena about the incident.
