Vic; reports that at this time, Sus; renigged on the offer and then decided to take the car back from the Victim.. because it was not registered, and immediately attempted to drive away. Victim; says that this was when she called Police. It was at this time, that I spoke to the suspect: David Pezza, who reports that, "its true that he sold her the car but in good fait, He goes on to say that the only reason why he was taking the car back from her, was because the car had his dealer plates on the vehicle, and he didn't want her to drive an unregistered motor vehicle. At this time (David Pezza) was immediately advised that he was under arrest for the above named charges. Suspect; was then handcuffed behind his his back, and taken and placed in the rear of Unit # 12 for transport to Police Headquarters for further processing. Also, be advised that (Suspect Joseph Scurese) was also placed under arrest for Conspiracy and Theft. Note: Joseph Scurese was in fact the driver who drove the Vehicle for David Pezza.

At Headquarters:

Suspects: were then processed as per procedure and then taken and placed in Cell Blocks 1 and 2.
Suspects: were then charged accordingly as follows: for David Pezza--- Motor Vehicle Title Offense 2C:21-4.8b(3) Forgery 2C:21-1a(2), Theft 2C:20-3a, Conspiracy 2C:5-2 A(1) under warrant no. W 2012 000543 & 546

For Joseph Scurese--- Theft 2C:20-3(A), Conspiracy 2C:5-2 A(1) under warrant no. W 2012 000542
Both having a court date of July 11, 2012 at 10:00 am. Bloomfield Municipal Court.

Vehicle was then towed by ECRB and the dealer plates were then tagged and placed into evidence locker A1.
Title Certificate, Dealer Registration, and Insurance cards were then placed and tagged as evidence into locker A2.


NOTE: Victim Bernadette Yates, did give a Voluntary Statement to Detective Thomas Fano in regards to this incident.



I am Detective Fano of the Bloomfield Police Dept and I am investigating an incident / crime that you were the victim of and has been reported to the Bloomfield Police Dept. This statement is being given by you in reference to that.

Q. What is your date of birth?

A. 02-19-88.

Q. What is your home address ?

A. 67 Columbia Ave. Newark, N.J.

Q. Do you read, write and understand the English language?

A. Yes.

Q. What was your last grade of education that you completed ?

A. 1 year of college.

Q. Are you willing to give a statement of your own free will about an incident that occurred and you have knowledge of ?

A. Yes Sir.

Q. Can you tell what happened that led the Police to be called to the Dunkin Donuts parking lot on Franklin St. ?

A. I was meeting with a guy who I contacted through Craigs List to purchase a car from. We gave the guy the balance of the money for the car and he gave me the title in return. He then told me that he was going to take the car because it was not registered. He then tried to drive away with the car and that is when we called Police. My boyfriend, Jaliyl Haithcoach, tried to step in front of the back plate when the guy tried to remove the plate and leave before Police came. The guy Dave came with another guy who had long gray hair and a beard. He is the one who took the final payment from me which was \$700.00 in cash.

Q. Did Dave tell you he had a dealership ?

A. Yes, he told us he had a dealership lot with cars on it but did not give us the address, instead he told us to meet him at the Dunkin Donuts on Franklin St.

Page 2. Statement

Last Monday, July 2nd. Jaliyl met with both of those guys, looked at the car and gave them a deposit of \$300.00 and planned to meet with them today.

Q. Do you know Dave's last name ?

A. No.

Q. Do you know the other guy's name with the gray hair that was with him ?

A. I know him as Joe.

Q. Who signed the title over during the transaction in the DD parking lot ?

A. Dave showed me the blank title and then asked me for my license so he could sign the title over. He then walked over to the car we were going to purchase and filed the back of the title out, signing the registered owner's name to the rear of the title and putting that zero dollars were paid for the car.

Q. What type of car were you are going to purchase from Dave and Joe ?

A. a 2001 Buick Real GS, silver in color.

Q. Did Dave give you a receipt for any of the cash that given to him by you ?

A. No.

Q. Do you believe that Dave and Joe were taking your money and the car too ?

A. Yes, because they would not give us the keys. Before I called the Police Jaliyl tried to stop them from leaving so we could have the Police check them out.

Q. The Police returned some money to you, how much of your money was returned?

A. \$930.00 was returned to me by the Police Officers.

Q. How much money are you out at this time ?

A. \$70.00 of our money.

Q. Is there anything else that you would like to tell me at this time ?

A. No.

Q. Is everything that you have stated to me the truth, so help you God ?

A. Yes.




