Dear Mr. Buglione:

Please forgive me for contacting you at your law office. However, there is no information on the Internet on how a citizen is supposed to engage the services of the Passaic County Ethics Board. I searched Passaic County's official website and there is no mention of the Ethics Board under the "departments" tab or anywhere else on the site. I learned that you are on the Ethics Board by examining your 2015 Financial Disclosure Statement at the Local Finance Board's website. After learning that you were an attorney, a subsequent web search led me to your law firm's name and fax number.

As an initial matter, would you please inform the other members of the Ethics Board of the problems I encountered trying to communicate with the Board? I believe that the Ethics Board should have a link on Passaic County's website to instruct citizens on the Board's existence and on how to communicate with the Board.

Also, I ask that you accept this letter as my complaint against Passaic County Freeholder Ronda Casson Cotroneo and that you forward it to the appropriate party for processing. My complaint is that Freeholder Cotroneo, according to the attached rosters, has not filed her Financial Disclosure Statement (FDS) for 2014 and 2015 despite N.J.S.A. 40A:9-22.6, which requires Local Government Officers to file annually.

According to her on-line bio, Freeholder Cotroneo is a practicing attorney, a former president of the Passaic County Bar Association and a past member of the District XI Ethics Committee. Given her background, I am confused as to why she failed to file her Financial Disclosure Form.
