Mr. Paff states that he contacted me directly - as a Board Member, since there was no other guidance on how to advance a complaint.


I have written to Mr. Paff under separate cover (which has been forwarded to you) to advise him that he needs to contact you directly regarding any Passaic County Ethics Board issues.
