Dear Mr. Paff:

This is in response to your OPRA request assigned as #W99796. I will respond to each section of your request in turn:

1. Notice of Violation or Notice of Dismissal or other document that resolved 12-029 (Love).

You will notice that the home address has been redacted. Pursuant to N.J.S.A. 47:1A-1, “a public agency has a responsibility and an obligation to safeguard from public access a citizen’s personal information with which it has been entrusted when disclosure thereof would violate the citizen’s reasonable expectation of privacy. Serrano v. South Brunswick Twp., 358 NJ Super, 352, 368-69 (App. Div. 2003); see also National Archives and Records Administration v Favish, 541 U.S. 157, 124 S.Ct. 1570 (U.S. March 30, 2004) (personal privacy interests are protected under FOIA). Further, the NJ Supreme Court has indicated that, as a general matter, the public disclosure of an individual’s home address “does implicate privacy interests.” Doe v. Poritz, 142 N.J. 1, 82 (1995).”

2. The minutes of the December 10, 2014 meeting apparently refer to another document that lists matters identified by numbers such as "III.A.10." I am having difficulty understanding whether each of the case disposed of at the December 10, 2014 meeting is one that I am already aware of from the LFB's responses to my prior requests. For each of the references bearing numbers III.A.1 through III.A.10, I would like whatever document that the Board members had in front of them, or were referring to, when considering those items.

These records are exempt from disclosure under OPRA (N.J.S.A. 47:1A-9). Therefore, the Division of Local Government Services (Division) has no records to provide in response to this portion of your request.

Pursuant to N.J.A.C. 5:35-1.2(a), “any complaints, statements, information, or documents obtained or prepared by the Board staff or the Board are deemed confidential and not subject to public disclosure during the course of the preliminary investigation or investigation to determine whether a violation of the Local Government Ethics Law has occurred.”
