The Board reviewed the administrative charges along with all relevant documentation, and Samuel Halpern's personal comments, in accordance with N.J.S.A. 43:1-3, to determine the possible impact this may have on Mr. Lynch's Application for Accidental Disability Retirement. Lynch purchased steroids for his personal use from the other officer, and at least once purchased the drugs of Correctional Facility property; Further, Lt Lynch did not initiat an arrest or take any law enforcement action concerning this illegal activity, he did not report the illegal activities, and he did not have a prescription for steroids.
	Lt. Lynch was made aware of the charges on April 9, 2015 and was suspended without pay effective April 10, 2015. A review of the relevant documents indicates that although this was an administrative matter, the Board noted the two instances of misconduct involving the sale and use of steroids and a separate event involving a cell phone. The Board determined that Mr. Lynch's instances of misconduct demonstrated a high degree of moral turpitude and there was a direct relationship with his duties as a County Correction Lieutenant with the County of Sussex. He contends that Mr. Lynch served the public honorably and well in his capacity as Corrections Officer up to the occurrences of misconduct during what wound end up being his last years of service. However, the Board noted that Mr. Lynch's purchase of illegal steroids for personal use on multiple occasions, and allowing the ongoing sale of such substances on the premises of Sussex County Jail with his knowledge is an egregious violation of his duties as a Correction Lieutenant. Further, by permitting a cell phone to be brought into the jail, he allowed the creation of a highly dangerous situation for the staff and inmates within the jail. The Board noted that, as a senior officer, he bears great responsibility for providing leadership and conformance to procedures. The receipt of a public pension is expressly conditioned upon the rendering of honorable service by a public officer. Based on the above, the Board voted for total forfeiture of Mr. Lynch's benefits, based on his PFRS service, due to his egregious misconduct. He is entitled to the refund of his accumulated pension contributions that were remitted during his membership. In a separate action, the Board determined that Mr. Lynch's Application for Accidental Disability benefits is moot because his total service and salary credit are forfeited. The Board also noted that the Settlement stipulates that he may never return to employment in a law enforcement position in NJ. (Motion by Trustee Loccke seconded by Trustee Bennett)
